Meeting Commenced at 7.00pm

Welcome & Karakia

Heather Lowery-Kappes greeted guests and invited Hana Lambert to open the meeting with a karakia.

Introductions

Heather Lowery-Kappes welcomed those in attendance and panel member introduced themselves. The panel consisted of the National Executive Committee and National Development Manager.

CDANZ Waiata

The recording of Teriu Lemon signing the CDANZ Waiata played while panel and attendees were invited to sign along in their homes.

Housekeeping

Paula Stenberg went over the meeting housekeeping including meeting communication protocols. Members were advised that the AGM was being recorded.

Establishment of Quorum

A quorum of 5% of voting members (15) is required. There were 55 participants in the meeting so Paula Stenberg provisionally declared that a quorum was established.

Register of Attendance & Apologies

Paula Stenberg advised that the record of attendance will be reported via Zoom. She then read the apologies received in advance via Survey Monkey and invited people to add any further apologies via the Chat.

Approval of Previous Minutes

Annual Report & Financial Report

Heather Lowery-Kappes offered an overview of the Annual Report and answered any questions arising via the chat.

The Annual Report was moved by Heather Lowery-Kappes and seconded by Raewyn Laurenson.

Hana-Maree Lambert presented the Financial Report including:

- Current Bank Balances
- Budget for FY22

The Financial Report was moved by Hana-Maree Lambert and seconded by Jane Field.

Remits and How to Vote

Paula Stenberg introduced Lauren Hughes as the Returning Officer. She then explained how the voting process would work, clarified who is an eligible voter and explained that in order for a remit to be passed it required 2/3 (66.66%) of eligible voted to be in the affirmative,

Lauren declared that she was aware of 25 Advance Votes which she would read alongside the published live poll results. By combining these two she would declare a provisional result for each of the three remits. The provisional results will be verified by Lauren Hughes and Koa Saxby operating as a Scrutineer the following day after they have adjusted for any ineligible or duplicate votes.

Remit 1. Amend the post-nominals for Full Members from FMCDANZ to MCDANZ

Paula Stenberg read the voting proposition and rationale for this Remit.

No questions were raised by membership prior to the vote.

The provisional results were:

Yes - 75 (25 Advance and 50 Live Poll) – provisionally passed with 100% support No - 0 (0 Advance and 0 Live Poll)

Abstain - 2 (2 Advance and 0 Live Poll)

Both Lauren Hughes and Paula Stenberg declared the remit, provisionally passed.

Remit 2. Reduce timeframe by one month, from effectively four months to three, for notifying and lapsing an overdue membership

Paula Stenberg read the voting proposition and rationale for this Remit.

No questions were raised by membership prior to the vote.

The provisional results were:

Yes - 67 (18 Advance and 49 Live Poll) - provisionally passed with 89% support No - 7 (6 Advance and 1 Live Poll) Abstain – 1 (1 Advance and 0 Live Poll)

Both Lauren Hughes and Paula Stenberg declared the remit, provisionally passed.

Remit 3. Ability to rejoin and resume membership type to reduce from five years to three years after 6 July 2021.

Paula Stenberg read the voting proposition and rationale for this Remit.

No questions were raised by membership prior to the vote.

The provisional results were: **Yes - 68 (23 Advance and 45 Live Poll) – provisionally passed with 90% support** No - 5 (2 Advance and 3 Live Poll) Abstain - 2 (0 Advance and 2 Live Poll)

Both Lauren Hughes and Paula Stenberg declared the remit, provisionally passed.

General Business

A member asked when the next National Conference would be held and Heather Lowery-Kappes explained that CDANZ is exploring the possibility of collaborating with CDAA to deliver conferences in alternate years. CDAA have dates scheduled for 2022.

Celebrations and Changes to the Executive

Heather Lowery-Kappes thanked everyone who serves CDANZ including the Membership Committee, Evaluation Team, Māori and Pacific Career Practitioners Network, Branch Committees, staff Koa Saxby, Lauren Hughes, the Admit Team and the National Executive Committee.

Jennie Miller was farewelled from the National Executive Committee having completed her maximum term of six years including roles of Secretary, Treasurer and President. She was thanked for her exceptional service.

Paula Stenberg was farewelled from the National Executive Committee having served for one year as Secretary. She was thanked for her contribution, especially in a year with two General Meetings.

Paula Rewi will remain on the National Executive Committee but will step down as Vice President. Cherie Perrow will take on the role of Vice President.

National Executive Members encouraged members to consider serving on the National Executive Committee. It is a rewarding role and we are always keen to hear from members interested to learn more. Please contact the President.
